Covid-19

We have continued to follow government guidelines, and so for the study session leading to the April 2022 exams, we have offered students the choice of online or face-to-face tutorials wherever possible. This is also currently the plan for the study session leading to the September 2022 exams. We will be regularly reviewing the type of courses that we offer to match student demand and ensure we are able to provide a consistent and continued high level of teaching throughout a changing environment.

Any provisional face-to-face course may be switched to online when it is finalised, or even between tutorial dates if deemed necessary. Our priority continues to be ensuring the safety of staff and learners. Thank you for your continued understanding.

Product development

Sound Revision is a set of audio files, designed to help students become more familiar with the most important aspects of the course. The audio files are split into a number of manageable topics based on the chapters in the Course Notes and are available to download through our Virtual Learning Environment. The recordings are perfect for use on-the-go or where taking folders and course notes is not practical. Sound Revision is now available again in Subjects CP1 and SA2 and may be re-introduced to other subjects in the future.

Online Classroom is now available in Subject SA7. The Online Classroom is a great alternative to a live tutorial but can also be a valuable add-on to a face-to-face or live online course.

Retaker materials

We strongly encourage that students have some Assignments or a Mock Exam marked to receive valuable feedback on their level of understanding and exam technique. Apprenticeships

BPP ActEd's **Level 7 Actuary Apprenticeship** continues to grow with over 40 employers having placed learners on the programme. The programme welcomed a further cohort of new learners in September 2021 and BPP ActEd is already accepting applications for the May 2022 intake. The Level 7 apprenticeship takes students up to the IFoA Associate qualification, studying and taking their exams in the normal way while completing a PPD-style portfolio throughout their apprenticeship. On completion of their associate exams, there is a final End-Point Assessment (EPA), which consists of a case study exam and a portfolio-based interview. After the apprenticeship, students can go on to complete the full IFoA Fellowship by taking the SP and SA exams outside of the apprenticeship.

BPP ActEd provides a comprehensive package of support for the IFoA exams as well as additional support and guidance for the portfolio and EPA. Levy funding of up to £18,000 per apprentice contributes to most of the cost of the support provided by ActEd, while IFoA membership subscriptions, exemption fees and exam fees are usually met by the employer. Some exam fees can also be covered by the levy if a student starts the apprenticeship with a number of exemptions.

The normal duration of the apprenticeship is 45 months, or less for those with exemptions, and subject to certain conditions, is open to new recruits, or existing trainees part-way through the Core Principles subjects.

The **Level 4 Actuarial Technician Apprenticeship** is currently being reviewed by the employer trailblazer group and the Institute for Apprenticeships following the withdrawal of the CAA qualification. We intend to run a new cohort in October 2022 with a slightly updated Apprenticeship Standard.
